THE UTILITY:



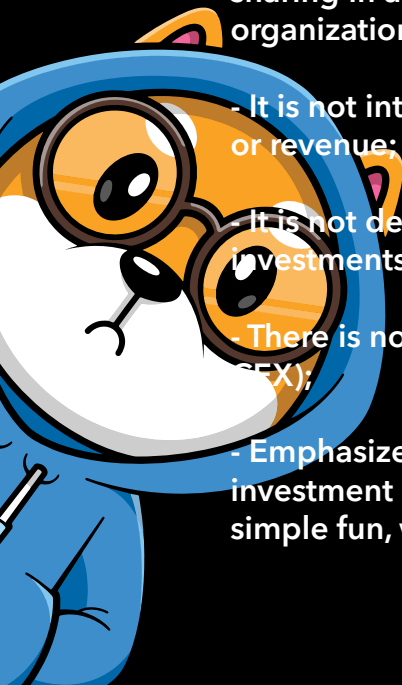
\$BBOBBI designed for community activation and vitality, has no function, utility, or intrinsic value, and no promise or expectation of financial return, profit, interest, or dividends.

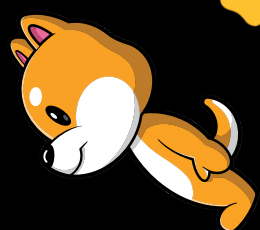
